In mid-2000,<sup>[21][22]</sup> Giuffre met Ghislaine Maxwell when working as a spa attendant at Donald Trump's private Mar-a-Lago club while reading a book about massage therapy.<sup>[17]</sup> Maxwell, a British socialite and daughter of the late media tycoon Robert Maxwell, approached Giuffre, noted the book that she was reading, inquired about her interest in massage, and offered her a potential job working for Epstein as a traveling masseuse with the assurance that no experience was necessary.<sup>[17]</sup> When Giuffre arrived at Epstein's Palm Beach home, she says he was naked lying down and Maxwell told her how to massage him. Right now, there are at least three related cases making their way through the Manhattan federal courts that probe how Wall Street may have supported and enabled Epstein. At the center of all of these is Staley, a former protégé of JPMorgan Chase CEO Jamie Dimon, probably the most powerful person in finance. Staley spent more than 30 years at JPMorgan, rose to be the CEO of its massive asset-management and investment-banking divisions, and went on to helm Barclays, one of the U.K.'s most important banks. Two of the suits are purported class-action suits brought by David Boies and Sigrid McCawley, the lawyers for Giuffre, on behalf of anonymous victims — one against JPMorgan, the other against Deutsche Bank, apparently one of the only banks that would take him after Staley briefly helmed a hedge fund. These suits argue that the banks made it possible for Boies to run his trafficking operation and turned a blind eye to suspicious activity because they were benefitting from his money and network.
