Paul, Weiss revenue subsequently rose from less than \$700 million in 2009 to more than \$3 billion in 2025, while Karp became one of the highest-paid lawyers in the world.^[24] Its importance to the firm also led Karp to entangle himself in the personal affairs of Apollo's CEO and co-founder, [Leon Black](#), and his representative, [Jeffrey Epstein](#).^[24]
